Description:	This course will introduce students to a range of health-related issues in representative literary texts of various authors and genres, including accounts of good health and bad, tales of disease, and explorations of perceptions and moods affected by varying psychological states, both as they reflect the health status of individuals, and as they comment on social and institutional sickness. The course focuses on the intersection of literature and health, both from the perspective of literature's ongoing interest in health issues, and from the perspective of understanding these issues by appreciating their expression (and learning how to analyze it) in literature. Although the focus of the course may vary from year to year in accordance with the selected texts, it is typically organized around a series of thematic units such as "domestic ailments," "plagues and nightmares," "physician-writers," and "cross-cultural medicine and healing." This year's iteration of the course will have a particular emphasis on non-fiction autobiographical works (memoirs).
