# **COURSE DESCRIPTION:**

Studies the microeconomic aspects of international trade, tracing its historical development from the theory of comparative costs to the theory of customs unions and tariffs. Topics include trade patterns, trade barriers and free trade versus protectionism, economic growth and development in the international economy, and international institutions. As well, this section examines the determinants of exchange rates and the relative merits of flexible and fixed exchange rates.

# **COURSE REQUIREMENTS:**

Three tests – the first two tests will count for a maximum of 30% each of the total grade, and the final exam will count for 40% of the total grade. All three tests will be open book. All tests will be 120 minutes in length. All three tests will require you to answer three of six questions.

- 1. Test 1: Wednesday, October 9
- 2. Test 2: Wednesday, November 13
- 3. Final exam: Exam period in December

#### **MISSED TESTS:**

There will be no make-ups for the two midterm tests. If a student misses one or both of these tests, the weight for the test(s) will be distributed among the remaining test(s). A deferred exam for the final exam will be granted only for medical reasons. In such cases students should submit a deferred exam application together with the supporting documents (attending physician's statement) to the Economics department to my attention. The date and time of the deferred exam will be set at a later date. Students who may require further extensions or accommodation will have to submit a formal petition to the Faculty.

Writing the final exam is IMPERATIVE! Students will not receive a grade unless they have written the final. If either of the first two tests is missed, the other test will count for 40% and the final for 60%.
