Missed Tests:

If students miss the midterm or final exams, a documented reason for missing the exam, such as illness, compassionate grounds, etc., which is confirmed by supporting documentation (e.g., doctor's letter) is required for accommodation from the Course Instructor. If students miss an in-class pop quiz, there is NO need to submit a document.

There will be no make-ups for the pop quizzes and midterm exam. The weight of a missed midterm (with legitimate document submitted) will be shifted to the final and no more than 50% of the pop quiz weight can be shifted to the final.
