Expanded Course Description

- The entire course will be run synchronously according to the RO's schedule (i.e., with 'live' sessions scheduled according to regular meeting times). Students are expected to meet at the scheduled times, via Zoom. To accommodate students who may be unable to attend live sessions, all live sessions will be recorded and made available for student

viewing. Zoom sessions, lecture slides, practice questions etc will all be posted on course Moodle, which will be the portal for all course related material. The link for all scheduled Zoom meetings will be posted on course Moodle.

Course Objectives

(1) Brief statement of the purpose:

Example: The purpose of this course is to assist students in developing a critical overview of issues related to International Trade. The course provides an introduction to the basis, consequences and policies of international trade and to the multilateral trading system. We will develop the basic theories of international trade leading to an understanding of why countries trade particular goods and services and firms invest abroad and what are the gains and potential losses from these transactions. These theories will help address policy issues such as what restrictions if any should be put on the free flow of goods, services and investment across international borders.

The specific outcomes of the course are that students will be able to:

- critically examine issues related to international trade.
- identify and describe current approaches to trade policy.
- apply theory to critically evaluate case studies
