Course Description:

Management of operations in today's business environment usually involves mathematical and statistical modeling. This course provides a working understanding of the operations management models and techniques such as process analysis, quality management, aggregate planning, inventory control, and material requirements planning.

Quizzes, Term Tests and Final Exam Policies

1. All quizzes, tests and exam will be done **online**.
2. Information concerning the Quizzes, Term Tests and Final Exams will be posted on course Moodle site.
3. There are 4 Quizzes, dates of which are given in the schedule below. Tests will be taken online using Moodle, and will be at the beginning of the class it is scheduled in. Quizzes will be about 20-30 minutes long. No makeups will be available, and best 3 out of 4 will count towards your overall grade.
4. There are two common term tests counting for 25% each towards the overall grade.
5. Both term tests and the final examination may consist of multiple-choice questions and worded questions.
6. If you miss a term test, the weight of one and only one missed test (25%) will be **automatically (no documents such as doctor notes needed)** transferred to the final examination. If you miss both term tests, your final examination will only weigh 60%.
7. The final examination will be **comprehensive** if you miss **any one or both** term tests. That is, if you miss one term test, or both you will be writing a final exam that includes material from the entire semester. Duration of Cumulative Final Exam might be different than the Regular Final Exam.
8. Formula sheets will be posted on course website. It will not be provided with Quizzes/Tests/Exam. Students are required to access formula sheet during Tests/Exam.
9. **There are no alternative exam dates and times for Term Tests.**
10. If students miss the Final Examination and have to defer the exam, the deferred exam will be a cumulative examination.

Followed by handing in a completed original Deferred Standing Agreement (DSA) form and supporting documentation directly to the main office of the School of Administrative Studies (282 Atkinson) and add your ticket number to the DSA form. The DSA and supporting documentation must be submitted no later than five (5) business days from the date of the exam. These requests will be considered on their merit and decisions will be made available by logging into the above-mentioned link. No individualized communication will be sent by the School to the students (no letter or e-mails).

Students with approved DSA will be able to write their deferred examination during the School's deferred examination period. **Deferred exams might take place during the regular exams period or in subsequent weeks depending on the course;** precise dates are known when the Office of the Registrar publishes the final exam schedule of the term. No further extensions of deferred exams shall be granted. The format and covered content of the deferred examination may be different from that of the originally scheduled examination. The deferred exam may be closed book, cumulative and comprehensive and may include all subjects/topics of the textbook whether they have been covered in class or not.

NOTE: To clarify the deferred standing final exam coverage, the deferred examination will be cumulative and cover all material for the semester. This applies to all students writing a deferred Final Exam including those who wrote both Test 1 and Test 2.
