Expanded Course Description

ECON 2350 is a continuation of ECON 2300. The course applies the analytical tools from ECON 2300 to analyze resource allocation in imperfectly competitive markets and factor pricing in alternative market structures. The course also introduces students to concepts and applications of game theory, and considers basic concepts of general equilibrium and externalities.

At the end of the course, students will be able to:

- understand the structure and underlying assumptions of the standard models used in microeconomic analysis and how the models' predictions change when the standard assumptions are relaxed;
- understand the basic tools of game theory and how to apply these to various settings;
- be able to identify and solve constrained optimization problems;
- demonstrate facility with the calculus-based methods used to analyze microeconomic problems;
- be able to explain in non-technical terms the fundamental economic intuition associated with the standard models.

Evaluation

The breakdown of the course grade is as follows:

- The **Midterm** will be held during class time in **mid-February**. **There will be no make-ups for the midterm exam.** If a student misses the midterm for a reason deemed acceptable by the instructor, the weight from the midterm will be transferred to the final exam, i.e. the final will account for 80% of the student's final grade. Appropriate documentation (e.g. a doctor's note) must be provided within 48 hours of the scheduled midterm date in order to transfer the weight from the midterm to the final exam.
- The **Final Exam** will take place **during the official exam period** and will include the material covered during the **entire course**.

Grading and Missed Tests

Grading: The grading scheme for the course conforms to the 9-point grading system used in undergraduate programs at York (e.g., A+ = 9, A = 8, B+ = 7, C+ = 5, etc.). Assignments and tests will bear either a letter grade designation or a corresponding number grade (e.g. A+ = 90 to 100, A = 80 to 90, B+ = 75 to 79, etc.) **Students may ask for their exam to be re-graded, but note that the whole exam will be re-graded (not just specific questions), so that the grade may end up going up or down.**

Assignment Submission: Proper academic performance depends on students doing their work not only well, but on time. Accordingly, assignments for this course must be received on the due date specified for each assignment.

Lateness Penalty: Assignments submitted later than the due date will not be accepted. Exceptions to the lateness penalty for valid reasons such as illness, compassionate grounds, etc., will be considered on a case-by-case basis by the Course Instructor, only when accompanied by supporting documentation (e.g., a doctor's letter).

Missed Tests: **There will be no make-ups for the midterm exam.** If a student misses the midterm for a reason deemed acceptable by the instructor, the weight from the midterm will be transferred to the final exam. Appropriate documentation (e.g. doctor's note) must be provided to the instructor **within 48 hours** of the scheduled exam date in order to transfer the weight from the midterm to the final exam.

A deferral for the **final exam** will be granted only for medical reasons. In such cases students should submit a deferred exam application **within 48 hours of the exam time** together with the supporting documents (attending physician's statement) to the Economics Department. The date and time of the deferred exam will be set at a later date. Students who may require further extensions or accommodation will have to submit a formal petition to the Faculty.
