There will be **5 active learning activities (ALA)** in this course. Each ALA is worth **1 mark**. If a student completes the works of an ALA and submit it in eClass by the due date, he or she will get 1 mark. On the other hand, if a student does not submit an ALA, he or she will get zero. The instructor will only count the marks of the best **5 ALAs out of 6 ALAs**. <u>Please note that an ALA will be graded solely based on the completeness of the answers, not based on the correctness of the answers.</u>
