COURSE OBJECTIVES:

This course provides an introduction to the current issues and procedures that are used in recruitment, selection and appraisal of employees in Canadian organizations. We will be reviewing such topics as Canadian legal standards, the utility of scientific approaches to selection, and the steps involved in validating a selection system.

- > Explain job-related performance and its relationship to competency-based HR systems.
- > Accurately and effectively measure job performance and its relationship to selection.
- > Design and conduct effective applicant screening and selection procedures.
- > Conduct effective interviewing using situational and behavioral interview techniques.
- > Implement selection and testing based on technical, ethical and legal requirements.

Weekly Online Quizzes: 10 x 1.5%

There are 10 online quizzes throughout the semester. Each quiz consists of 15 True/False questions, and will be posted on eClass each week, following the lectures on corresponding topics. The quizzes are "open-book" and will be completed online individually.

Each quiz will be available for a calendar window of **FIVE DAYS** (120 hours) following posting. For example, online quiz #1 will be posted at 11:00am, Tuesday, January 16. The window for Quiz #1 then will be closed at 11:00am, Sunday, January 21. Once you launch the quiz, it must be completed within **20 MINUTES** – you cannot return to it later.

Please use a wired internet connection while completing quizzes to avoid any internet interruptions. After the window for an online quiz is closed, you will receive feedback on which of your answers was correct or incorrect. To get the full marks for each weekly quiz, you must answer all questions correctly.

Weekly Online Discussions: 3 x 5.0%

This course takes place entirely online. Although "class participation" cannot take place in the traditional sense, there is a great deal of opportunity for interaction with peers and your instructor. Throughout the semester, **THREE** online discussion topics will be introduced. You are expected to take part in each online discussion during the week when they are scheduled. To be clear, you are required to participate in each discussion topic within **SEVEN** days (168 hours) of it being posted by the instructor.

For example, online discussion topic #1 will be posted at 11:00 am, Tuesday, January 23, you will have SEVEN days (168 hours) to submit your posts for credit. The discussion window for Topic #1 then will be closed at 11:00 am, Tuesday, January 30. ALL LATE POSTS AFTER THIS TIME WILL NOT BE AWARDED ANY MARKS.

A grade of 5% will be assigned to each online discussion topic based on quality of contribution. You will be able to earn marks by engaging your peers, encouraging conversations, offering comments and suggestions, and sharing your thoughts. To gain the full marks for each online discussion topic, you must write your posts with a total of **500-600 words**, as well as make comments on at least **TWO** posts from your classmates. Marks can be taken away for inappropriate comments that do not show respect and civility. Individuals who do not participate in online discussions should not expect to be rewarded for this dimension of performance.

Take-Home Mid-Term Exam: 25%

The take-home mid-term exam is scheduled at 7:00 pm - 10:00 pm, Friday, February 16, 2024. This means that students will receive exam questions at 7:00 pm, and then must submit their answers to the course website no later than 10:00 pm. It is imperative that students attend the take-home mid-term exam since *there will be no other alternative dates to write a make-up exam*.

The midterm exam will be three (3) hours, open-book, and covering all materials uploaded before the midterm (i.e., recorded lectures for Week 1-5, and textbook chapters 1-5). More details will be provided closer to the exam date.

Take-Home Final Exam: 40%

The take-home final exam will be scheduled during the formal examination period for the semester by the Registrar Office. Once the instructor receives exam details (date and time) from university administrators, this information will be posted on the course website "Announcements" board, as well as on the York

University website http://www.yorku.ca. It is imperative that students attend the take-home final exam since there will be no other alternative date to write the final exam.

The final exam will be three (3) hours, open-book, and covering all materials uploaded throughout the semester (i.e., recorded lectures for Week 1-13, and textbook chapters 1-10). More details will be provided closer to the exam date.

Note: Not all the material covered in the textbook will be discussed in class. Conversely, some of the materials presented in the recorded lectures will not be in the textbook. You will be responsible for all of the materials in both the assigned textbook chapters and in the recorded lectures.

STANDARDS OF PERFORMANCE:
