Land Acknowledgment

Course Overview

Course Description

Examines the theory and practice of policy making and public administration as well as the machinery of government, with particular reference to Canada. It discusses who makes policy, how policy is developed and implemented, and how the system is controlled and evaluated.

This course examines the theory and practice of public administration and management, with a particular focus on Canada and Canadian institutions. Students will be exposed to various theories of organizing governments, delivering services and interacting with the public and various stakeholders. In particular, students will gain an understanding of the how government

functions, how political actors interface with bureaucracy, how ethics guide public servants, how government is financed and the various ways in which core services are delivered to the public.

Course Learning Objectives

At the end of the course, students will:

- 1. Acquire a foundational understanding of the theoretical tools of public administration as a field of study.
- 2. Evaluate alternative theoretical approaches to the examination of public administration and of their respective strengths and limits.
- 3. Analyze and critique the complexity of public administration in terms of mixes of values, interests, competing orientations, and other factors, and of the ubiquity and effect of the evaluation of policies.
- 4. Gain a comprehensive understanding of different types and functions of public organizations in Canada.
- 5. Gain an appreciation for complexity of issues and challenges facing public sector organizations and public sector professionals.
- 6. Analyse public administration issues and to present the results of those explorations clearly, concisely, and in compelling form in written and oral communication.
- 7. Develop analytical and research skills that are essential for pursuing advanced studies in the field of public administration.

Course Format and Organization

This course will be held in-person and will be in seminar format. Each class session will include lecture format, visual components and group discussions. Expect to read 20+ pages a week. Readings must be prepared for the class according to the course schedule to effectively understand the lectures and course content. Attendance is strongly recommended for this seminar course.

Reflection Papers: 20%

Between Reflection times, please submit (within eClass) a short reflection (max. 500 words) on the readings, class discussion of your own personal growth <u>as a Public Administrator</u>. You are expected to share briefly two things that you learned and one thing that challenged your assumptions or helped you grow. Continuity Assignment #1: In this you will assignment you will write two papers. Continuity Assignment #2: The final part of this assignment is to investigate and answer, as you progress through the course, what has changed or reinforced your career direction. You are writing back to yourself (refer to Continuity Assignment #1) in the second (3 pages or 750 words) assignment and evaluating your first option. You are encouraged to demonstrated what you have learned, please use citations from the course text, readings, class discussion, current events or other resources you have encountered this year. **DUE DATE: APRIL 8**th

Group Assignment—Briefing Note and Snacks 35%

In a random group of 5 (possibly less depending on final class numbers) you will choose a topic of political significance to group members. Ideas can come from the list below. Each student will find an article or resource that is aligned with their own political ideologies to share with the group. In reading each other's articles and working together your group will write one 300-500 word briefing note, including the recommended option, and authored by each group member (we will talk more about this in class).

In the **last two classes**, each group will present not only your groups briefing note but also the group process that your group engaged in to arrive at a consensus and non-partisan document. Individually, you can talk about how your own political views informed the articles/resource that you contributed.

The written document will be graded out of 10% of overall grade **DUE DATE: MARCH 25**th The group presentation will be graded out of 20% of overall grade (all group members need to be given time to speak and will receive the same grade). **DUE DATE: MARCH 25**th or **APRIL 1**st

Snacks on the week that you are NOT presenting will be 5% of your overall grade. (We will discuss the pedagogy and social justice issues around this together.)

We will discuss this more in class, including building a list of possible-topic options.
