Course Overview

Course Description

This course deals with different sampling techniques and their applications to management problems. Survey design, pilot surveys, use of focus groups, in-person interviews, mail surveys and polling, will also be dealt with. Prerequisite: AP/ECON 2500 3.00 or AP/ADMS 2320 3.00, or, for students with equivalent preparation, permission of the coordinator.

By the end of this course, students will be able to:

- Effectively utilize a series of quantitative techniques in real world scenarios
- Understand the importance of ethical research and the proper procedures for conducting primary and secondary research
- Design, create and present research related projects
- Design, create and test research instruments in various different forms
- Understand the limitations and advantages of specific research methodologies

All classes will be held on campus. During the lecture, material will be covered as described in the course schedule.
