Course Objectives

(1) Brief statement of the purpose:

This course will examine the theory of labour economics. Subjects covered include labour supply, labour demand, labour market equilibrium, investment in human capital, labour mobility, union, and the structure of compensation.

- critically examine issues related to functioning of labour markets.
- identify and describe current approaches to policy.
- apply theory to critically evaluate case studies

- 4. Compensating Wage Differentials Chapter 8
- 5. Investment in Human Capital Chapter 9
- Migration Chapter 11 and supplement (to be determined)
- 7. The Structure of Compensation Chapters 10, 13
- 8. Union Chapter 14
