### **COURSE DESCRIPTION**

The objective of this course is to familiarize students with how business managers can use economic concepts and tools to make optimal business decisions. The emphasis of this course is on the *application* of microeconomic theory to business. So, our primary focus will be on relating theory to real life business situations.

### **COURSE REQUIREMENTS**

**Two tests**. All students must write the final exam, which will be held during the April exam period (April 8-25). This exam will be 120 minutes in length. The final will count for 60% of the total grade for this course.

As well, **all students must write one of the two term tests**. These tests will both be 120 minutes in length and will count for 40% of the total grade.

All three tests will require you to answer three of six questions. All the tests will be closed book – no phones, no laptops, no written notes, not textbook.

1. Test 1: Tuesday, February 11

- 2. Test 2: Tuesday, March 11
- 3. Final exam: Exam period in April

### MISSED TESTS

A deferred test will be granted **only for serious medical reasons**. In such cases students should submit a deferred test application together with the supporting documents (attending physician's statement and phone number) to the Economics department to my attention. The date and time of the deferred test will be set at a later date. Students who may require further extensions or accommodation will have to submit a formal petition to the Faculty.
