## **COURSE OBJECTIVES:**

This course is designed to provide an introductory survey of basic human resource concepts and functions. In addition, the nature and complexity of human resource management, the environmental context within which human resource decisions are made, and the interactions between key human resource practices, will be stressed. Topics include human resources planning, job analysis and work design, recruitment and selection, training and development, performance management, compensation, safety and health, and labour relations.

#### Weekly Online Quizzes: 10 x 1.5%

There are 10 online quizzes throughout the semester. Each quiz consists of 15 True/False questions, and will be posted on eClass each week, following the lectures on corresponding topics. The quizzes are "open book" and will be completed online individually.

Each quiz will be available for a calendar window of **FIVE DAYS** (120 hours) following posting. For example, online quiz #1 will be posted at 11:00am, Tuesday, May 13. The window for Quiz #1 then will be closed at 11:00am, Sunday, May 18. Once you launch the quiz, it must be completed within **15 MINUTES** – you cannot return to it later.

Please use a wired internet connection while completing quizzes to avoid any internet interruptions. After the window for an online quiz is closed, you will receive feedback on which of your answers was correct or incorrect. To get full marks for each weekly quiz, you must answer all questions correctly.

## Weekly Online Exercises: 4 x 5.0%

Throughout the semester, **FOUR** online exercises will be introduced to help you learn key HR practices. You are expected to complete each online exercise during the week when they are scheduled. To be clear, you are required to participate in each online exercise within **SEVEN** days (168 hours) of it being posted by the instructor.

For example, online exercise #1 will be posted at 11:00am, Tuesday, May 20, you will have SEVEN days (168 hours) to submit your posts for credit. The submission window for Exercise #1 then will be closed at 11:00am, Tuesday, May 27. ALL LATE SUBMISSIONS AFTER THIS TIME WILL NOT BE AWARDED ANY MARKS.

A grade of 5% will be assigned to each online exercise based on the quality of the answer. Individuals who do not participate in online exercises should not expect to be rewarded for this dimension of performance.

#### **Online Mid-Term Exam: 25%**

The online mid-term exam is scheduled at 7:00 pm - 9:00 pm, Tuesday, June 10. It is imperative that students write the online mid-term exam since *there will be no other alternative dates to write a make-up exam*.

The midterm exam will be open-book, covering all materials uploaded before the midterm (i.e., recorded lectures for Week 1-5, and textbook chapters 1-7). More details will be provided closer to the exam date. The format will be multiple-choice questions and scenario-based short-essay questions. More details will be provided closer to the exam date.

#### **Online Final Exam: 40%**

The take-home final exam will be scheduled during the formal examination period for the semester by the Registrar Office. Once the instructor receives exam details (date and time) from university administrators, this information will be posted on the course website "Announcements" board, as well as on the York University website http://www.yorku.ca. It is imperative that students attend the take-home final exam since **there will be no other alternative date to write the final exam**.

The final exam will be three (3) hours, open-book, covering all materials uploaded after the midterm exam (i.e., recorded lectures for Week 8-13, and textbook chapters 8-15). The format will be scenario-based short-essay questions. More details will be provided closer to the exam date.
