## **Course Objectives**

#### (1) Brief statement of the purpose:

Example: The purpose of this course is to assist students in developing a critical overview of issues related to International Trade. The course provides an introduction to the basis, consequences and policies of international trade and to the multilateral trading system. We will develop the basic theories of international trade leading to an understanding of why countries trade particular goods and services and firms invest abroad and what are the gains and potential losses from these transactions. These theories will help address policy issues such as what restrictions if any should be put on the free flow of goods, services and investment across international borders.

- identify and describe current approaches to trade policy.
- · apply theory to critically evaluate case studies
