# Course Overview

### **Course Description**

This course examines social institutions and the ideologies of law within the context of public policies through case studies and the case study method of analysis. The foundations of law and practice are examined within liberal democratic societies. Informed by classical and contemporary sociological and legal theorists and their perspectives, and the analysis of current pressing public policy issues and concern, the course will explore the critical role of law and its practice in liberal democratic societies.

The course will consider the field of the *Sociology of Law* through an examination of structures and processes that shape the development of law as a sociocultural product. The *Sociology of Law* is surveyed through the works of the major theorists in the discipline from the classical -- Karl Marx, Max Weber and Emile Durkheim – to contemporary movements such as structural-functionalism, conflict theory, and critical legal studies. An emphasis on the socio-political context will help to inform an understanding of law within liberal democratic societies. The *Sociology of Law* will seek to further a critical

understanding of law and how it influences social values and behavior within liberal democratic societies. Students will be challenged to examine and to consider the legal implications of contemporary public policies issues, concerns, and practices, through the analysis, consideration, and presentation of case studies, through the case study method, and how this shapes our understanding of justice.

An integral aspect of the course will be its Globally Networked Learning (GNL) component that will be held over an one-week intensive each semester. Students will have a virtual learning experience with students at universities in other countries. This will provide students with an opportunity to enhance their inter-cultural sensitivity and communications skills as well as learning about law and its practice in other societies and countries.

# **Course Learning Objectives**

By the end of this course:

- Students will have furthered their understanding of some of the theoretical foundations of the sociology of law and the dynamics of law within liberal democratic societies.
- Students will have further developed their case study analysis and presentation skills through an examination of contemporary public policy issues and the law.
- Students will have demonstrated their ability to summarize and synthesize complex ideas, concepts, and legal theories through their analysis and presentation of public policy case studies.
- Students will have identified relevant and interesting "sociology of law" research topics and presented research proposals and papers on their topics in the field.
- Students will have developed a sophisticated knowledge of the field and discipline of the *Sociology of Law*.
- Students will have refined and further developed their inter-cultural and communications skills through the interaction and working with students at universities in other countries.
- Students will have learned about law and how it is practiced in other societies and countries.

### **Submitting Assignments**

Assignments for this course must be received within the timeframes specified and will be submitted through eClass ("Turnitin" or "Assignments" or through the Discussion Forum as noted in each assignment. Students are expected to save a copy of all assignments and may be asked to resubmit if any difficulties in submission arises. Note times of submission are aligned with the start of your class time.

# Group Messaging Tools

### Plagiarism

Plagiarism is defined as misusing another person's published or unpublished work by presenting their ideas, writing or other intellectual property as one's own without proper acknowledgement (<u>Senate Policy on Academic Honesty</u>, section 2.1.3.). There are several acts that are plagiarism, for example:

• copying content word-for-word from a source without proper citation; • paraphrasing from a source without proper citation; submitting work you have already submitted for another course without the instructor's approval; • rewording someone else's work which you submit as your own;

• having a third-party complete work in whole then submitting it as one's own (also known as contract cheating).

Although plagiarism is often thought to involve words and ideas, it can also involve drawings, paintings, photographs, programming code, statistics, presentations, musical scores, among other types of content. Even if the act of plagiarism was unintentional, you can still receive a penalty. To avoid plagiarism, keep good track of any outside sources you use, and ensure that you cite sources properly. ### Turnitin
